### Rules and Regulations

1. At least one representative must attend the Captain's Meeting (Friday, June 16th at 4:30 PM – 6:00PM at Hoffman's Marina West - 608 Green Avenue in Brielle, NJ or 26954.143498.0) to register and receive pertinent tournament information.
2. All boats must return tournament entry card at weigh in.
3. Boat may leave at conclusion of Captain's meeting but final weigh-in will be on Saturday, June 17th at 6:00PM. The scale will be either Hoffman's Marina East or Hoffman's Marina West, to be announced at the Captain's meeting June 16<sup>th</sup>.
4. **Check-out anytime after Captain's meeting adjourns.**
5. All boats must finish via the Manasquan Inlet to qualify for prizes.
6. All boats must be visible from **Hoffman's Marina East** prior to 6:00PM June 17th in order to weigh-in eligible Makos. NO EXCUSES.
7. VHF, Channel 69 will be used for all tournament related communications. Please keep it clear. Channel 70 will be utilized as a first alternate.
8. This is a **MAKO (and Thresher, see # 22 below) ONLY** tournament; **150lb minimum to qualify for ANY prizes**. It is requested that all other sharks be tagged and released. This is a tournament about big fish and conservation.
9. All makos, 66"and over in length, will be judged by weight only. If they are not 150lbs, THEY DO NOT QUALIFY.
10. All sharks must be caught using rod and reel; 130 class maximum.
11. All boats must report any mako caught, 66"and over, to a Committee Boat via VHF channel 69, immediately after the shark has been landed.
12. Boats shall not fish within a half a mile of another boat. While underway, please try to avoid established chum slicks.
13. **All boats fish at their own risk.** The captain and crew are solely responsible for deciding whether to fish or not. The captain and crew are solely responsible for all actions and decisions made on their boat during the course of the tournament. The captain and crew are solely responsible for all personal injuries and property damage that occurs on board. Neither the tournament, the Tournament Committee, nor any agent or representative of the Tournament Committee (collectively, the "Tournament Committee") is responsible for the negligent, reckless, intentional or other conduct of the captain, crew or guest of any boat or any other participant in the tournament and the Tournament Committee cannot be held liable for any personal injury or property damage on board any tournament boat. Further, the undersigned hereby releases and discharges the Tournament Committee, The Brett T. Bailey Foundation, its officers and members and Hoffman's Marina from all causes of action, damages and/or demands, in law or equity, which the undersigned ever had, now have, or hereafter can, shall or may have by reason of any matter, cause or thing whatsoever with respect to the tournament from the beginning of the world.
14. Any boat assisting a disabled vessel must report the circumstances to a Committee Boat, via channel 69, although the Tournament Committee shall have no responsibility of any kind or nature with respect to such disabled vessel.
15. Positively no transferring of sharks between vessels.
16. All sharks shall be weighed in their natural state. No jaws wired.
17. The Tournament Committee has the right to retain all eligible Makos for inspection by a Tournament Officer and/or a marine biologist.
18. The Tournament may be canceled by the Tournament Committee.
19. **You may leave from any inlet but must return to Manasquan Inlet and weigh in at the Hoffman's Marina by 6pm on June 17<sup>th</sup>. See rule #6 above**
20. **All Tournament Committee decisions are final.**
21. In case of a tie the prize money will be awarded to the fish that is weighed in first.
22. In the event no qualifying makos are weighed in, the prize money will then go to the largest Thresher shark over 150lbs. If no makos or threshers qualify, the winners will be picked randomly out of a hat.
23. All winners must submit their social security number before prizes are awarded and sign tournament acknowledgment and release forms.
24. All contestants must read these Tournament Rules and Regulations and agree to abide by them. All Federal and State Fishing Regulations, rules, statutes and other laws apply to this tournament and its participants. If a boat, its captain or any member of its crew violates any federal or state statute, regulation, rule or law or any of these Tournament Rules and Regulations, the violating boat, including the captain and crew of that boat, will be automatically disqualified from the Tournament and will be deemed to have forfeited any entitlement to awards, prizes or calcuttas relating to the tournament.
25. **Maximum 6 anglers per boat. Maximum of 6 lines fished at any one time.**
26. All participating boats must possess and may be asked to show proof of an NMFS Angling, General or Charter Headboat HMS Permit, which allows you to recreationally fish for and/or retain any regulated Atlantic HMS (including sharks). All fishing must take place 3+ miles offshore. **In order to be eligible for tournament awards, prizes and calcuttas, fish must be caught in compliance with all Tournament Rules and Regulations, including all applicable federal and state statutes, rules, regulations and laws and all state and federal size land possession limits (all of which are incorporated by reference into the Tournament Rules and Regulations). Any boat that violates a Tournament Rule or Regulation, including the federal and state statutes, rules, regulations and laws and state and federal size land possession limits incorporated into those Rules and Regulations, shall be disqualified from the tournament and not entitled to receive any tournament awards, prizes or calcuttas.**

I AM THE OWNER/OPERATOR OF THE FISHING VESSEL IDENTIFIED HEREIN, AND I SPECIALLY CONFIRM TO THE BRETT T.
